Māori and Iwi Housing Innovation Framework for Action (MAIHI): Report Back on the Implementation of Te Maihi o te Whare Māori

Portfolio Housing

On 29 June 2022, the Cabinet Social Wellbeing Committee:

- 1 **noted** that:
 - 1.1 in May 2020, Cabinet endorsed the Māori and Iwi Housing Innovation Framework for Action (MAIHI) Framework for Action, and agreed that policy and investment decisions, as well as implementation of housing solutions for Māori, should apply the MAIHI Framework [CAB-20-MIN-0229.02];
 - 1.2 in June 2021, SWC noted the 12-month progress update on MAIHI and invited the Associate Minister of Housing (Māori Housing) to report back to SWC by 30 June 2022 on further progress [SWC-21-MIN-0148];
- 2 **noted** the progress made through the implementation of the MAIHI Framework for Action, as outlined in the paper under SWC-22-SUB-0126;
- 3 **noted** that:
 - 3.1 in March 2022, Te MAIHI Whare Wānanga was hosted in Te Tai Tokerau and delivered nationally online;
 - 3.2 this was the largest Te MAIHI Whare Wānanga to date, with attendees from Ngāti Hine, Ngāti Wai, Ngāti Rēhia, Te Rarawa, Ngāpuhi and Ngāti Whātua, Māori housing providers from Te Tai Tokerau, Te Tūāpapa Kura Kāinga officials, and the Minister of Housing and Associate Housing Ministers in attendance;
 - 3.3 the overarching theme from the Whare Wānanga is that Māori are ready to lead their own housing solutions and the Crown needs to remove barriers to Māori progress;
- 4 **invited** the Associate Minister of Housing (Māori Housing) to report back to SWC by July 2023 on further progress of MAIHI, MAIHI Ka Ora and Te MAIHI Whare Wānanga.
